<b>Notification of Reportable Drug Price Increase</b>	Effective July 1, 2023, prescription drug manufacturers licensed with the state of Florida must provide notification to the Department of Business & Professional Regulation of each reportable drug price increase on the effective date of such reportable drug price increase as required under Section 499.026, Florida Statutes (“F.S.”).

**DEFINITION OF TERMS PER SECTION 499.026, F.S.**

TERMS
<b>Course of therapy:</b> The recommended daily units of a prescription drug pursuant to its prescribing label for 30 days or the recommended daily dose units of a prescription drug pursuant to its prescribing label for a normal course of treatment which is less than 30 days.
<b>Manufacture:</b> A person holding a prescription drug manufacturer or a nonresident prescription drug manufacturer permit under s. 499.01.
<b>Prescription drug:</b> Has the same meaning as in s. 499.003 and includes biological products but is limited to those prescription drugs and biological products intended for human use.
<b>Wholesale acquisition cost (“WAC”):</b> With respect to a prescription drug or biological product, the manufacturer’s list price for the prescription drug or biological product to wholesalers or direct purchasers in the United States, not including prompt pay or other discounts, rebates, or reductions in price, for the most recent month for which the information is available, as reported in wholesale price guides or other publications of drug or biological product pricing guides or other publications of drug or biological product pricing data.
<b>Reportable drug price increase:</b> Means, for a prescription drug with a WAC of at least \$100 for a course of therapy before the effective date of an increase: <ol style="list-style-type: none"> <li>1. Any increase of 15 percent or more of the WAC during the preceding 12-month period; or</li> <li>2. Any cumulative increase of 30 percent or more of the WAC during the preceding 3 calendar years. In calculating the 30 percent threshold, the manufacturer must base the calculation on the WAC in effect at the end of the 3-year period as compared to the WAC in effect at the beginning of the same 3-year period.</li> </ol>
