Professional License Renewals!

Don't Delay, Don't Hesitate, And Don't Procrastinate!

In an effort to allow those holding professional elevator licenses with the State of Florida additional time to renew, the Bureau opened up the renewal period on **September 1st** this year. This change provides an additional 30 days of lead time than renewal periods in previous years, and allows license holders an additional 30 days to submit all renewal requirements. License holders that are now eligible to begin renewal include **Registered Elevator Companies, Certificates of Competency Holders, Certified Elevator Technicians, and Certified Elevator Inspectors**. Don't delay! Personnel working with expired certificates are subject to citations as of January 1st. Continuing Education

Get started early! Waiting until the last minute may cause delays in license renewals for individuals with professional licenses from the Bureau.

61C-5.0085 Continuing Education Requirements.

- (1) Continuing Education Requirements.
 - (a) To renew a certificate of competency or a certified elevator inspector credential issued by the division pursuant to Chapter 399, F.S., a person must submit, in addition to the other requirements specified in Rule 61C-5.007, F.A.C., proof of completion within the current annual licensure period of 8 hours of approved continuing education, including at least one course hour related to safety in elevator construction, alteration, modification, repair or maintenance.

The Bureau of Elevator Safety issues annual credentials, registration and licensing renewal applications with a due date on or before December 31 of each calendar year. All certifications and licenses related to elevator professionals become effective January 1 of each calendar year.

IF YOU DO NOT PROPERLY RENEW, YOU WILL BE OPERATING IN VIOLATION OF THE LAW, WHICH IS A SECOND DEGREE MISDEMEANOR UNDER SECTION 399.11, FLORIDA STATUTES, AND MAY RESULT IN AN ADMINISTRATIVE FINE UP TO \$1,000.

PLEASE NOTE: To ensure timely processing, please include only one renewal per envelope.

Certified Elevator Technician/ Certificate of Competency Annual Renewal Requirements

Return the bottom portion of this notice to the address listed below, along with the following:

1. Payment of the \$50 license fee. Make checks payable to the Bureau of Elevator Safety. Purchase orders will not be accepted. To ensure proper processing, please **write the license number on the check.**
2. Proof of successful completion of 8 hours of approved continuing education, completed sometime in 2021.
3. Proof of General Liability Insurance coverage, currently in force, in the minimum amounts of \$100,000 per person and \$300,000 per occurrence for the remainder of 2021 and for 2022.
