PARK OWNER PROSPECTUS FILING STATEMENT

A copy of this filing statement should accompany the filing of each prospectus for a mobile home park. Pursuant to Section 723.011(1)(d), Florida Statutes, the proper fees must be paid for each prospectus filed. If lots in a park were permitted by the Department of Health and Rehabilitative Services (HRS) prior to June 4, 1984, the fees will be based on the following:
