Instructions for Filing a Petition for Appointment of an Election Monitor

A completed petition, copy of the first notice of election, and qualified voter list of unit owners must be received in this office no later than fourteen (14) days in advance of the scheduled election date.

- 1. Please print clearly and fill out the entire petition. At least fifteen (15 %) percent of the association's qualified voters must sign the petition, including the date, and their unit number. Qualified voters who own multiple units must sign separately for each unit.
- 2. Mail or hand-deliver the original completed petition, a copy of the first notice of election, and the association's list of qualified voters to:

- 3. If the petition is deficient, the unit owner's representative will be notified and be afforded five (5) calendar days from receipt of the notice to correct all deficiencies.
- 4. Upon appointment of an election monitor, the board and petitioner's representative will be notified.
- 5. Pursuant to Florida law, the association is responsible to pay all costs incurred for the election monitor.
