EMERGENCY ORDER 2024-07

WHEREAS, Hurricane Ian made landfall on Florida’s western Gulf Coast as a major hurricane and caused significant damage across the State; and

WHEREAS, Hurricane Ian and the damage it caused poses a significant threat to the entire State of Florida and, as such, requires timely precautions to protect the State’s communities, critical infrastructure, and general welfare; and

WHEREAS, the Governor, in recognition of and in response to this emergency, issued Executive Order 22-218 on September 23, 2022, as amended or renewed by Executive Order 22-219 on September 24, 2022, by Executive Order 22-268 on November 21, 2022, by Executive Order 23-21 on January 19, 2023, by Executive Order 23-60 on March 17, 2023, by Executive Order 23-104 on May 15, 2023, by Executive Order 23-139 on July 13, 2023, by Executive Order 23-176 on September 8, 2023, by Executive Order 23-214 on November 6, 2023, by Executive Order 24-02 on January 4, 2024, by Executive Order 24-36 on March 1, 2024, by Executive Order 24-80 on April 29, 2024, by Executive Order 24-137 on June 27, 2024, and by Executive Order 24-174 on August 23, 2024, pursuant to the authority vested in him by Article IV, Section 1(a) of the Florida Constitution, the Emergency Management Act, as amended, and all other applicable laws; and

WHEREAS, the Governor, in Executive Order 22-218, as amended or renewed by Executive Orders 22-219, 22-268, 23-21, 23-60, 23-104, 23-139, 23-176, 23-214, 24-02, 24-36, 24-80, 24-137, and 24-174 authorized each state agency to suspend the provisions of any regulatory statute, order, or rule if strict compliance with the provision would in any way prevent, hinder, or delay necessary action in coping with this emergency.

NOW, THEREFORE, I, MELANIE S. GRIFFIN, Secretary of Florida’s Department of Business and Professional Regulation (“Department” or “DBPR”), pursuant to the authority granted to me by Executive Order 2022-218, as amended or renewed by Executive Orders 22-219, 22-268, 23-21, 23-60, 23-104, 23-139, 23-176, 23-214, 24-02, 24-36, 24-80, 24-137, and 24-174, find that timely execution of the mitigation, response, and recovery aspects of the State’s emergency management plan, as it relates to Hurricane Ian, is negatively impacted by the application of certain regulatory statutes related to the Department. Pursuant to this authority, I previously executed the DBPR Emergency Orders 2022-03, 2022-04, 2022-07, 2022-08, 2023-01, 2023-02, 2023-03, 2023-04, 2023-05, 2023-08, 2023-10, 2024-01, 2024-03, and 2024-05, which, in part, suspended and tolled various deadlines and geographical scope limitations, and waived fee provisions, to mitigate the burdens DBPR licensees and applicants faced from Hurricane Ian. The previous deadlines in the aforementioned orders are imminent, yet many applicants and licensees still face storm-related hardships. Therefore, I order the following extensions of DBPR’s prior Emergency Orders, which were previously extended by the DBPR Emergency Orders 2022-08, 2023-01, 2023-02, 2023-03, 2023-05, 2023-08, 2023-10, 2024-01, 2024-03, and 2024-05:

Department Emergency Order 2022-03

1. The entirety of Department Emergency Order 2022-03 is extended until October 22, 2024, unless extended by subsequent order.

Department Emergency Order 2022-04

2. Paragraphs 6 and 7 of Department Emergency Order 2022-04 are extended until October 22, 2024, unless extended by subsequent order.

Department Emergency Order 2022-07

3. The entirety of Department Emergency Order 2022-07 is extended until October 22, 2024, unless extended by subsequent order.

Department Emergency Order 2023-04

4. The entirety of Department Emergency Order 2023-04 is extended until October 22, 2024, unless extended by subsequent order.

Retroactive Application: This entire Order retroactively applies from August 23, 2024, onward.


