Application Review

Architecture Endorsement

Salvatore Bordonaro

Mr. Bordonaro was present and sworn. Mr. Hicks presented the file and commented that Mr. Bordonaro's degree was not accredited. Ms. Clark commented that this was a state endorsement application based on Chapter 481.213(3)(b), F.S. She advised the board to review the laws in affect at the time Mr. Bordonaro received his license in his state and the laws of Florida.

MOTION: Mr. Gustafson moved to deny based on Mr. Bordonaro's education was not substantially equivalent at the time of licensure.

SECOND: Mr. Hall seconded the motion.

Mr. Bordonaro commented that he had a license in New York and practiced since 1991. He commented that he received a Bachelor of Science in Architectural Technology. Ms. Clark commented that Florida had always required a 5-year professional degree for licensure in Florida. Mr. Bordonaro asked if licensure would be considered on education and experience. Ms. Clark replied in the negative. Mr. Bordonaro requested to withdraw his application in lieu of being denied.

Michael Riley

Mr. Riley was present and sworn. Mr. Hicks presented the file and commented that Mr. Riley's degree was a Bachelor in Environmental Design and not an accredited degree. Mr. Riley commented that he had a Bachelors degree in Environmental Design and a 5-year Bachelor of Science in Architectural Engineering at the University of Kansas. Mr. Schreiber commented that it was not an accredited NAAB degree. Ms. Clark commented that Mr. Riley was applying under Chapter 481.213(3)(a), F.S., which refers back to Chapter 481.209(1)(b), F.S.

MOTION: Mr. Gustafson moved to deny based on Chapter 481.213(3)(a), F.S. and 481.209(1)(b), F.S.

SECOND: Mr. Gonzalez seconded the motion.

Mr. Riley commented that he had applied for certification under NCARB. Ms. Clark referred Mr. Riley to Chapter 481.213(3)(c), F.S. and advised that he would be required to have been licensed prior to June 30, 1984. Mr. Riley requested that his application be tabled to allow him to submit additional NCARB information. Mr. Riley waived the 90 day rights under Chapter 120.60, F.S.

Mr. Gustafson withdrew his motion.

MOTION: Ms. Del Bianco moved to table the application.

SECOND: Mr. Schreiber seconded the motion and it passed unanimously.
