### **II. Major Issues/Actions**

- The board reviewed and approved the applicant and continuing education ratification lists.
- Ms. Chastain presented the 2007-08 third quarter financial statement.
- Ms. Clark informed the Board of the new provision of Section 120.541, F.S., regarding a Statement of Estimated Regulatory Cost (SERC) if a rule impacts small businesses.
- The Board reviewed and approved the interior design Associate and Bachelor degree programs for Southwest Florida College.
- The Board voted to repeal the last sentence of Rule 61G1-12.001(3), FAC, "an architectural firm may not offer services to the public under a firm name which contains only the name of an individual not licensed as a professional engineer or registered architect in any state" based on JAPC comments. The Board voted that this change would not impact small businesses.
- The Board voted that the changes to Rule 61G1-21.003, FAC, regarding the interior design continuing education handbook would not impact small businesses and directed Ms. Clark to proceed.
- The Board voted that the changes to Rule 61G1-24.002, FAC, regarding the architecture continuing education handbook would not impact small businesses and directed Ms. Clark to proceed.
- The Board approved Chairman Kuritzky's letter to Secretary Drago regarding budget input.
- Mr. Ehrig and Mr. Kuritzky commented about the National Council of Architectural Registration Boards (NCARB) meeting and discussed the six-month notification requirement for the intern development program.
