GENERAL SESSION

The meeting was called to order by Jim Evetts, at 9:00am. Mr. Moody gave the Invocation. Mr. Lenois led the Pledge of Allegiance.

PROSECUTING ATTORNEY'S REPORT – Ian Brown

For the month of January 2017, the overall license activity case load was 846, up from 836 in December of 2016, and up from 788 in January of 2016.

There were 432 cases currently in Legal to be reviewed, 127 cases awaiting probable cause panel/initial review complete, 11 cases set for probable cause, 41 cases where probable cause had been found/administrative complaints filed, 3 settlement stipulation approved, 6 informal hearings requested, 0 cases awaiting outside action, 36 cases ready for default, 89 formal hearings requested, 4 cases referred to DOAH, 45 cases in settlement negotiations, 0 case pending board date, 45 cases set for board presentation, 3 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.
