The meeting was called to order by Rick Kane, at 9:00am. Mr. Boyette gave the Invocation. Mr. Korelishn led the Pledge of Allegiance.

EXECUTIVE DIRECTOR'S REPORT – Daniel Biggins

Mr. Biggins welcomed our new members Mr. Donovan, Mr. Cesarone and Mr. McCullers to the Board, and informed the board we still have two vacancies to be filled on the board.

Mr. Biggins mentioned that there will be a brief training in the near future on FDLE criminal history results.

Mr. Biggins also mentioned that the Recovery Fund Committee will be conducting a meeting via conference call on April 3rd, 2018.

CHAIRMAN'S REPORT – Rick Kane

Mr. Kane welcomed the new board members and informed them that if they have any questions, do not hesitate to ask.

PROSECUTING ATTORNEY'S REPORT – Ian Brown

Mr. Brown gave the following report:

For the month of January 2018, the overall license activity case load was 822, up from 798 in December of 2017, and down from 846 in January 2017.

There were 342 cases currently in Legal to be reviewed, 267 cases awaiting PC Panel/ Initial Review Completed, 13 cases set for probable cause, 40 cases where probable cause had been found/administrative complaints filed, 2 settlement stipulation approved, 3 informal hearings requested, 0 cases awaiting outside action, 31 cases ready for default, 77 formal hearings requested, 0 case referred to DOAH, 7 cases in settlement negotiations, 0 case pending board date, 35 cases set for board presentation, 5 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of January 2018, 109 cases were closed; this included 28 Final Orders with Discipline.

ATTORNEY GENERAL'S REPORT – Rachel Clark

BENTO, JOSHUA – REQUEST FOR INFORMAL HEARING

Mr. Bento was not present.

Ms. Clark presented this case stating Mr. Bento's application for a Certified Roofing Contractor's license was denied at the November 2017 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in December of 2017. Mr. Bento timely requested board reconsideration.

After discussion, the board voted to uphold the previous denial.

BLACK, DONALD – REQUEST FOR INFORMAL HEARING

Mr. Black was not present.

Ms. Clark presented this case stating Mr. Black's application for a Certified Roofing Contractor's license was denied at the November 2017 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in December of 2017. Mr. Black timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application.

CARTER, PERRY – RECONSIDERATION

Mr. Carter was present.

Ms. Clark presented this case stating Mr. Carter's application to qualify Poire's Underground Services, LLC, as an additional business entity, was denied at the November 2017 meeting of the Board for failure to demonstrate the qualifying agent would have the ability to supervise the construction work and business activities of the organization, as required by section 489.119, Florida Statutes and Rule 61G4-15.0024, Florida Administrative Code. The Notice of Intent to Deny was filed in December of 2017. Mr. Carter timely requested board reconsideration.

After discussion, the board voted to vacate the denial and allowed the applicant to withdraw his application.

HUBBARD, PATRICK – PETITION FOR DECLARATORY STATEMENT

Mr. Hubbard was present.

Ms. Clark presented this case stating Mr. Hubbard filed a petition for declaratory statement on January 29, 2018. The petition was noticed in the Florida Administrative Register on February 6, 2018. Ms. Clark noted the petitioner asks the Board for clarification of s.489.113 (9)(b)2, Fla. Statutes, with regard to the need for an engineer or architect for Division 1 or 2 work performed pursuant to this section.

After discussion, the board declines to answer due to the petition being too vague and does not state a particular set of circumstances to which the statute in question would apply as required by s.120.565, Fla. Statute.

MANGEL, JOHN – PETITION FOR DECLARATORY STATEMENT

Mr. Mangel was not present.

Ms. Clark presented this case stating Mr. Mangel filed a petition for declaratory statement on January 29, 2018.. Ms. Clark noted the petitioner asks the Board for clarification of s.489.103 (7)(a)2, Fla. Statutes, with regard to owner builder permits for rental property damaged by hurricane.

After discussion, the board declines to answer due to the petition being too vague and does not state a particular set of circumstances to which the statute in question would apply as required by s.120.565, Fla. Statute.

MEJIA, CARLOS ABENER – REQUEST FOR INFORMAL HEARING

Mr. Mejia was present.

Ms. Clark presented this case stating Mr. Mejia's application to qualify Best Rescreen, LLC as an additional business was denied at the November 2017 meeting of the Board for failure to demonstrate the qualifying agent would have the ability to supervise the construction work and business activities of the organization, as required by section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in December of 2017. Mr. Mejia timely requested board reconsideration.

After discussion, the board voted to vacate the denial and approve the application contingent.

MILLER, BRIAN and BROTZ, ALAN – PETITION FOR DECLARATORY STATEMENT

Mr. Miller and Mr. Brotz were present.

Ms. Clark presented this case stating Mr. Miller and Mr. Brotz filed a petition for declaratory statement on July 11, 2017, October 17, 2017 and January 12, 2018. The petition was noticed in the Florida Administrative Register on February 6, 2018. Ms. Clark noted the petitioner asks the Board for clarification of rule 61G4-12.011(15), Florida Administrative Code, as it relates to a licensed

pool/service contractor installing or replacing electrical circuits on the load side of the dedicated pool equipment disconnect panel when installing or replacing pool equipment.

After discussion, the board declines to answer for the following reasons The Petitioner's petition appears to apply to the conduct of another, which is inappropriate for a declaratory statement as outlined in Rule 28-105.001, Fla. Administrative Code. The Petition appears to relate to general applicability, which has previously been addressed in rule. The Board does not have jurisdiction over Chapter 553, Fla. Stat.

PRADO, MICHAEL ELWOOD – RECONSIDERATION

Ms. Clark presented this case stating Mr. Prado's application for a Certified Roofing Contractor's license was denied at the July 2017 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code.
