PROSECUTING ATTORNEY'S REPORT – Ian Brown

For the month of February 2019, the overall license activity case load was 1476, down from 1520 in January of 2019, and up from 822 in January 2018.

There were 707 cases currently in Legal to be reviewed, 434 cases awaiting PC Panel/ Initial Review Completed, 72 cases set for probable cause, 24 cases where probable cause had been found/administrative complaints filed, 0 settlement stipulation approved, 23 informal hearings requested, 0 cases awaiting outside action, 35 cases ready for default, 104 formal hearings requested, 1 cases referred to DOAH, 6 cases in settlement negotiations, 0 case pending board date, 70 cases set for board presentation, 0 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.
