The meeting was called to order by Brian Cathey, Chair, at 9:00am. Mr. Lenois gave the Invocation. Mr. Cobb led the Pledge of Allegiance.

EXECUTIVE DIRECTOR'S REPORT – Drew Winters

Mr. Winters gave the following report:

Mr. Winters distributed the Monthly Board Report which provides the monthly complaint and investigation numbers.

Mr. Winters informed the board that the Ad Hoc committee will convene at the July 2014 meeting. He also let the board know that the \$100 fee holiday would take effect during the upcoming renewal cycle for certified license holders, and would be applied to the registered license renewal fees in 2015.

Mr. Winters announced that Mr. Del Vecchio and Mr. Dachevall were not confirmed by the Senate, so June 2014 would be their last meeting as board members.

CHAIRMAN'S REPORT – BRIAN CATHEY

Mr. Cathey gave the following report:

Mr. Cathey presented Kristin Beall, a former board member, with a plaque and thanked her for her service.

With nothing further to report the board voted unanimously to approve this report.

PROSECUTING ATTORNEY'S REPORT – KYLE CHRISTOPHER

Mr. Christopher gave the following report:

For the month of April 2014, the overall license activity case load was 504, down from 520 in March 2014 and down from 291 in April 2013.

There were 339 cases currently in Legal to be reviewed, 4 cases set for probable cause, 45 cases for which probable cause had been found/administrative complaints filed, 1 settlement stipulation approved, 1 informal hearing requested, 6 cases awaiting outside action, 11 cases ready for default, 32 formal hearings requested, 2 cases referred to DOAH, 4 cases in settlement negotiations, 0 cases pending board dates, 19 cases set for board presentation, 39 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of April 2014, 67 cases were closed.

For the month of April 2014, the overall unlicensed activity case load was 604, up from 460 in April 2014.

There were 460 cases currently in Legal to be reviewed, 10 cases where administrative complaints had been filed, 1 settlement stipulation approved, 10 informal hearings requested, 0 cases awaiting outside action, 15 cases ready for default, 17 formal hearings requested, 0 cases referred to DOAH, 2 cases in settlement negotiations, 0 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of April 2014, 47 cases were closed.

15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2014. Mr. Caballero's timely requested board reconsideration.

After discussion, the Board voted to vacate the denial. Mr. Bryant subsequently withdrew his application.

Mr. Barnhart noted the petition seeks the Board's interpretation as to whether certain fire restoration work falls within the definition of "contracting" under section 489.105, Florida Statutes, such that a party performing such work is required to obtain a license from the Department of Business and Professional Regulation prior to engaging in such work as described in the petition for declaratory statement.

After discussion, the petition was withdrawn by the petitioner.

WALTER FITZPATRICK– PETITION FOR DECLARATORY STATEMENT

Mr. Fitzpatrick was present.

Mr. Barnhart presented this case stating Walter Fitzpatrick filed a petition for a declaratory statement on April 3, 2014. The petition was noticed in the Florida Administrative Register on April 9, 2014. Mr. Barnhart noted the petition seeks the Board's interpretation as to whether sections 489.105(3)(j), (k), and (l), Florida Statutes, allow petitioner to perform electronic leak detection for pools in Florida.

After discussion, the board voted that they did not find facts supporting the need for a license.

KERRY GUTIERREZ– REQUEST FOR INFORMAL HEARING

Mr. Gutierrez was present with counsel.

Mr. Barnhart presented this case stating Mr. Gutierrez application for initial issuance of a certified building contractor's license was denied at the March 2013 meeting of the board for applicant is involved in an open prosecution contrary to section 455.213(3), Florida Statutes. The Notice of Intent to Deny was filed in April of 2014. Mr. Cicero timely requested board reconsideration.

After discussion, the Board voted to vacate the denial. Mr. Gutierrez subsequently withdrew his application.

JOHN HALBROOKS– REQUEST FOR INFORMAL HEARING

Mr. Halbrooks was present with counsel.

Mr. Barnhart presented this case stating Mr. Halbrooks application for initial issuance of a certified general contractor's license was denied at the January 2014 meeting of the Board for failing to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-

15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in February of 2014. Mr. Halbrooks timely requested board reconsideration.

After discussion, the Board voted to uphold the denial.

AUSTIN HEARELL– REQUEST FOR INFORMAL HEARING

Mr. Barnhart presented this case stating Mr. Hearell's application for initial issuance of a certified class B air conditioning contractor's license was denied at the March 2014 meeting of the Board for the application materials indicated the applicant lacked good moral character, contrary to section 489.111, 455.227 (1)(c), and 489.129 (1)(b), Florida Statutes based on applicant's criminal history as detailed in the application materials. Mr. Barnhart presented this case stating Mr. Horn's application to qualify an additional business entity was denied at the February 2014 meeting of the Board for failing to demonstrate the qualifying agent would properly supervise the construction work and business activities, as required by section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in April of 2014. Mr. Horn timely requested board reconsideration.
