EXECUTIVE DIRECTOR'S REPORT – DREW WINTERS

CHAIRMAN'S REPORT – ROBERT MOODY

Mr. Moody gave the following report:

Mr. Moody asked the Board to recognize Ms. Amanda Wynn for 10 years of service to the Department.

Mr. Moody informed the Board that Mr. Kyle Christopher has replaced Mr. Paul Waters as the Chief Prosecuting Attorney for the Board. Mr. Moody congratulated Mr. Waters on his promotion to Deputy General Counsel, and welcomed Mr. Christopher to the Board.

Mr. Moody informed the Board that demolition specialty contractor's license is progressing and that a meeting is scheduled for next week with Professional Testing, Inc., on exam development. Mr. Moody also thanked the National Demolition Association for their support and assistance.

Mr. Moody asked the Board to recognize two former Board members, Mr. Scott Greenberg and Mr. Jerry Hussey.

Mr. Moody then gave the floor to Mr. Fred Dudley, Esq., who informed the Board that he and Mr. Hussey have been working together for the past year to address concerns the

Board has had. Mr. Dudley stated that they have formed a non-profit corporation and have put together a presentation that will be formally presented to the Board at next month's meeting. Mr. Moody requested that Mr. Winters be sure to agenda this item for next month's General Session meeting.

With nothing further to report the board voted unanimously to approve this report.

PROSECUTING ATTORNEY'S REPORT – KYLE CHRISTOPHER

Mr. Christopher gave the following report:

For the month of May 2013, the overall case load was 289, down from 291 in April 2013, and up from 256 in May 2012.

There were 141 cases currently in Legal to be reviewed, 29 cases set for probable cause, and 35 cases where probable cause had been found/administrative complaints filed. 0 settlement stipulations had been approved, 0 informal hearings had been requested, and 13 cases were awaiting outside action. 6 cases were ready for default, 14 had requested formal hearings, and 1 case was referred to DOAH. 2 cases were in settlement negotiations, 1 case was pending a board date, and 27 cases were set for board presentation. 20 cases were awaiting final orders. 0 cases were under appeal and 0 cases had been reopened.

For the month of May 2013, 96 cases were closed.

STEVEN BECKER – REQUEST FOR INFORMAL HEARING

Mr. Becker was present with counsel

Mr. Barnhart presented this case stating Mr. Becker's application to qualify an additional business entity was denied at the April 2013 meeting of the board for failing to demonstrate the qualifying agent would properly supervise the construction work and business activities, as required by Section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in May of 2013. Mr. Becker timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and allow Mr. Becker to withdraw the application

STEVEN BOUSCHER – REQUEST FOR INFORMAL HEARING

Mr. Bouscher was present with counsel

Mr. Barnhart presented this case stating Mr. Bouscher's application to qualify an additional business entity was denied at the March 2013 meeting of the board for failing

to sufficiently demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code; and because the applicant misrepresented details on his application, contrary to Sections 489.111 and 455.213, Florida Statutes. The Notice of Intent to Deny was filed in April of 2013. Mr. Bouscher timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to allow Mr. Bouscher to withdraw the application.

PAUL CASTELL – REQUEST FOR INFORMAL HEARING

Mr. Castell was present.

Mr. Barnhart presented this case stating Mr. Castell's application for initial issuance of a certified mechanical contractor's license was denied at the February 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in March of 2013. Mr. Castell timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to approve the application as a Class A air conditioning contractor's license.

WILLIAM EARL – REQUEST FOR INFORMAL HEARING

Mr. Earl was not present.

Mr. Barnhart presented this case stating Mr. Earl's application to qualify an additional business entity was denied at the March 2013 meeting of the board for failing to demonstrate the qualifying agent would properly supervise the construction and business activities, as required by Section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in April of 2013. Mr. Earl timely requested board reconsideration, and further requested a continuance of this hearing to the July 2013 meeting of the board.

After discussion the board voted to deny the request for a continuance and voted to uphold the denial of the application.

CHRISTOPHER FELDER – PETITION FOR VARIANCE AND WAIVER

Mr. Felder was not present.

Mr. Barnhart presented this case stating Mr. Felder filed a petition for a variance and waiver on April 18, 2013. The petition was noticed in the Florida Administrative Register on May 31, 2013. Mr. Barnhart noted the petition appears to be seeking a waiver of Rule 61G4-16.005, Florida Administrative Code, to extend the duration of validity of his exam scores beyond the 4 year time limit, and to allow him to submit his expired test scores with an application for license in lieu of retaking the examination. Mr. Barnhart asked the board to consider the petition and grant or deny the waiver as required.

After discussion the board voted to deny the petition for failing to establish a need and for failing to submit the petition in the proper form.

MARIA FUENTES – REQUEST FOR INFORMAL HEARING

Ms. Fuentes was present with counsel.

Mr. Barnhart presented this case stating Ms. Fuentes' application for initial issuance of a certified residential contractor's license was denied at the February 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in March of 2013. Ms. Fuentes timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to allow the applicant to withdraw her application.

CLAIR GLANTZ – REQUEST FOR INFORMAL HEARING

Mr. Glantz was present.

Mr. Barnhart presented this case stating Mr. Glantz' application for initial issuance of a certified building contractor's license was denied at the March 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2013. Mr. Glantz timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to approve Mr. Glantz' application.

HORACIO GONZALEZ – PETITION FOR A DECLARATORY STATEMENT

Mr. Gonzalez was present.

Mr. Barnhart presented this case stating Mr. Gonzalez filed a petition for a declaratory statement on April 24, 2013. The petition was noticed in the Florida Administrative Register on May 6, 2013. Mr. Barnhart noted the petitioner is asking whether his general contractor's license is sufficient to prepare site-specific drawings, specifications, or plans for the design and construction of single-family and two-family dwellings; swimming pools, spas, or screened enclosures; or any other structure not exceeding 1,200 square feet or one story in height. Mr. Barnhart asked the board to consider whether or not the petition meets the criteria for a declaratory statement, and to dismiss or answer as appropriate.

After discussion the board voted that the petitioner had standing. After further discussion the board voted that the size of the single-family and/or two-family dwelling is not limited in size or story and that the petitioner can prepare and submit site-specific drawings, specifications, or plans for the design and construction of those dwellings.

The motion was amended to clarify that the board does not have jurisdiction over the building department's prerogative to accept or reject those plans for cause.

PABLO GONZALEZ – REQUEST FOR INFORMAL HEARING

Mr. Gonzalez was present.

Mr. Barnhart presented this case stating Mr. Gonzalez' application for initial issuance of a certified roofing contractor's license was denied at the March 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2013. Mr. Gonzalez timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and allow Mr. Gonzalez to withdraw the application.

CARLOS HERNANDEZ – REQUEST FOR INFORMAL HEARING

Mr. Hernandez was not present and requested a 60 day continuance.

After discussion the board voted to grant the continuance.

BRIAN HIGGINS – REQUEST FOR INFORMAL HEARING

Mr. Higgins was present.

Mr. Barnhart presented this case stating Mr. Higgins' application for initial issuance of a certified building contractor's license was denied at the April 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in May of 2013. Mr. Higgins timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to allow Mr. Higgins to withdraw the application.

TODD KNAPP – REQUEST FOR INFORMAL HEARING

Mr. Knapp was present.

Mr. Barnhart presented this case stating Mr. Knapp's application to qualify an additional business entity was denied at the March 2013 meeting of the board for failing to demonstrate the qualifying agent would properly supervise the construction work and business activities, as required by section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in April of 2013. Mr. Knapp timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to approve the application, contingent upon Mr. Knapp providing proof of W2 employment with the company to be qualified, and proof of ownership in the company to be qualified.

KEVIN KOUSHEL – REQUEST FOR INFORMAL HEARING

Mr. Koushel was present.

Mr. Barnhart presented this case stating Mr. Koushel's application for initial issuance of a certified building contractor's license was denied at the January 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in February of 2013. Mr. Koushel timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and, at the request of the applicant, voted to approve the application as a downgrade to a certified residential contractor's license.

NICK MASSIMO – REQUEST FOR INFORMAL HEARING

Mr. Massimo was present.

Mr. Barnhart presented this case stating Mr. Massimo's application for a change of status of his certified residential pool/spa contractor's license was denied at the May 2013 meeting of the board for failing to sufficiently demonstrate financial stability and responsibility, pursuant to Section 489.115, Florida Statutes, and Rule 61G4-15.006, Florida Administrative Code. Mr. Massimo, after having been made aware of his hearing rights, requested board reconsideration prior to the filing of the Notice of Intent to Deny.

After discussion the board voted to vacate the denial of the application and to approve Mr. Massimo's application.

STEVEN MAYHEW – REQUEST FOR INFORMAL HEARING

Mr. Mayhew was present.

Mr. Barnhart presented this case stating Mr. Mayhew's application for initial issuance of a certified tower specialty contractor's license was denied at the March 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2013. Mr. Mayhew timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to approve Mr. Mayhew's application.

ROBERT MILLER – REQUEST FOR INFORMAL HEARING

Mr. Miller was not present.

Mr. Barnhart presented this case stating Mr. Miller's application for initial issuance of a certified residential contractor's license was denied at the March 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2013. Mr. Miller timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to allow Mr. Miller to withdraw the application.

TODD OIFER – REQUEST FOR INFORMAL HEARING

Mr. Oifer was not present.

Mr. Barnhart presented this case stating Mr. Oifer's application for initial issuance of a certified roofing contractor's license was denied at the March 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2013. Mr. Oifer timely requested board reconsideration.

After discussion the board voted to uphold the denial of the application.

NATHAN QUINN – REQUEST FOR INFORMAL HEARING

Mr. Quinn was present.

Mr. Barnhart presented this case stating Mr. Quinn's application for initial issuance of a certified plumbing contractor's license was denied at the May 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code; and because the application materials indicated the applicant lacked good moral character, contrary to Section 489.111, Florida Statutes. Mr. Quinn, after having been made aware of his hearing rights, requested board reconsideration prior to the filing of the Notice of Intent to Deny.

After discussion the board voted to vacate the denial of Mr. Quinn's application, and to approve the application.

PATRICK REED – PETITION FOR DECLARATORY STATEMENT

Mr. Reed was not present.

Mr. Barnhart presented this case stating Mr. Reed filed a petition for a declaratory statement on May 21, 2013. The petition was noticed in the Florida Administrative Register on May 31, 2013. Mr. Barnhart stated the petitioner does not state in his request which he seeks the Board to interpret. However, Petitioner appears to be requesting the Board's interpretation of Section 489.105(3)(a), Florida Statutes, as to

whether his general contractor's license is sufficient to perform installation of wireless zwave technology routers, zwave thermostats, door locks and wireless zwave cameras that will allow absentee vacation home owners to monitor and regulate the status of their homes. Any work that involves high or low voltage line work would be subcontracted to a local licensed qualified vendor. Mr. Barnhart asked the board to consider whether or not the petition meets the criteria for a declaratory statement, and to dismiss or answer as appropriate.

After discussion the board voted to deny the petition, as they found the petitioner to lack the proper standing, and because the petition did not appear to be in the proper format.

DAVID RICH – REQUEST FOR INFORMAL HEARING

Mr. Rich was present.

Mr. Barnhart presented this case stating Mr. Rich's application for initial issuance of a certified roofing contractor's license was denied at the April 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in May of 2013. Mr. Rich timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to approve the application.

SUN STAR ENERGY, LLC – PETITION FOR DECLARATORY STATEMENT

Two representatives from Sun Star Energy, LLC were present.

Mr. Barnhart presented this case stating Sun Star Energy, LLC filed a petition for a declaratory statement on May 21, 2013. The petition was noticed in the Florida Administrative Register on May 31, 2013. Mr. Barnhart stated the petitioner does not state which statute he seeks the Board to interpret. However, the petitioner appears to be requesting the Board's interpretation of Section 489.105 (3)(m), Florida Statutes, as to whether a plumbing contractor can install the company's solar water heating system. The petitioner filed an addendum to the petition, clarifying that the definition of their plumbing contractor's license states they do not need an outside (roofing) contractor to install a solar water heating system, which consists of an 80 gallon water heater tank and 4x10 solar collector, which is normally installed on the roof. The petitioner seeks the Board's opinion as to whether their plumbing license is sufficient to install the solar water heating system without a roofing contractor's license. Mr. Barnhart asked the board to consider whether or not the petition meets the criteria for a declaratory statement, and to dismiss or answer as appropriate.

After discussion the board the petitioner had the proper standing. After further discussion the board voted that a plumbing contractor can install a solar water heating system and all appurtenances.

RONALD TATE – REQUEST FOR INFORMAL HEARING

Mr. Tate was present

Mr. Barnhart presented this case stating Mr. Tate's application for initial issuance of a certified specialty structure contractor's license by endorsement was denied at the March 2013 meeting of the board for failing to demonstrate he had passed an examination that is substantially equivalent to the required Florida certification examination; failing to demonstrate that he has a license in a state whose criteria are substantially similar to Florida's; and failing to demonstrate that he has attained the experience requirements for certification in Florida, as required by Section 489.115 (3), Florida Statutes. The Notice of Intent to Deny was filed in April of 2013. Mr. Tate timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to approve the application, as Mr. Tate provided proof that he has passed the Florida certification exam.

JOHNNY UNE – REQUEST FOR INFORMAL HEARING

Mr. Une was present.

Mr. Barnhart presented this case stating Mr. Une's application for initial issuance of a registered roofing contractor's license was denied at the May 2013 meeting of the board for failing to sufficiently demonstrate financial stability and responsibility, pursuant to Section 489.115, Florida Statutes, and Rule 61G4-15.006, Florida Administrative Code. Mr. Une, after having been made aware of his hearing rights, requested board reconsideration prior to the filing of the Notice of Intent to Deny.

After discussion the board voted to vacate the denial of the application and to approve the application.

DAVID DE JESUS POSADA – REQUEST FOR INFORMAL HEARING

Mr. Posada was present.

Mr. Barnhart presented this case stating Mr. Posada's application for initial issuance of a certified mechanical contractor's license was denied at the January 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in February of 2013. Mr. Posada timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and to approve the application.
