GENERAL SESSION

The meeting was called to order by Rick Kane, at 9:00am. Mr. Donovan gave the Invocation. Mr. Evetts led the Pledge of Allegiance.

EXECUTIVE DIRECTOR'S REPORT – Daniel Biggins

Mr. Biggins requested the Board excuse absences for the following board members:

With nothing further to report the board voted unanimously to approve this report.

CHAIRMAN'S REPORT – Rick Kane

Mr. Kane mentioned that the Endorsement Committee convened via conference call on June 11th and that he wanted to thank the staff, Mr. Boyette and Mr. Cobb. Mr. Kane also recognized Mr. Cobb for his service to the Board, and thanked him for his leadership.

With nothing further to report the board voted unanimously to approve this report.

PROSECUTING ATTORNEY’S REPORT – Ian Brown

Mr. Brown gave the following report:

For the month of April 2018, the overall license activity case load was 1,035, up from 944 in March of 2018, and up from 940 in April 2017.

There were 547 cases currently in Legal to be reviewed, 213 cases awaiting PC Panel/ Initial Review Completed, 10 cases set for probable cause, 74 cases where probable cause had been found/administrative complaints filed, 2 settlement stipulation approved, 7 informal hearings requested, 0 cases awaiting outside action, 30 cases ready for default, 72 formal hearings requested, 1 case referred to DOAH, 3 cases in settlement negotiations, 0 case pending board date, 40 cases set for board presentation, 36 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of April 2018, 150 cases were closed; this included 31 Final Orders with Discipline.

Mr. Brown also introduced Attorney, Brook McCormick from OGC who will be joining him at upcoming CILB meetings.

With nothing further to report the board voted unanimously to approve this report.

ATTORNEY GENERAL’S REPORT – Rachel Clark

BECK, CHRISTOPHER P. – PETITION FOR VARIANCE AND WAIVER

Mr. Beck was present.

Ms. Clark presented this case stating the Mr. Beck filed a petition for Variance or Waiver on April 30, 2018. The petition was noticed in the Florida Administrative Register on May 8, 2018. Ms. Clark noted The Petitioner is requesting a variance or waiver from the test results expiration time period as set forth in Rule 61G4-16.009, Florida Administrative Code.

After discussion, the Board voted to deny the request, no hardship.

CAMPBELL, LEWIN – REQUEST FOR INFORMAL HEARING

COZZI, LISA – REQUEST FOR INFORMAL HEARING

Ms. Clark presented this case stating Ms. Cozzi’s application to qualify Eagle Eyes Construction Inc, was denied at the February 2018 meeting of the Board for failure to appear as required by Rule 61G4-15.0021, Florida Administrative Code, and the applicant failed to demonstrate the qualifying agent would have the ability to supervise the construction work and business activities of the organization, as

required by section 489.119, Florida Statutes, Rule 61G4-15.0024, Florida Administrative Code. Notice of Intent to Deny was filed in March of 2018. Ms. Cozzi timely requested board reconsideration.

After discussion, the board voted to uphold the denial.

GARCIA MENDEZ, CARLOS ESTEBAN – REQUEST FOR INFORMAL HEARING

Mr. Garcia Mendez was present

Ms. Clark presented this case stating Mr. Garcia Mendez’s application to qualify Taa Builders, LLC, was denied at the March 2018 meeting of the Board for failure to appear as required by Rule 61G4-15.0021, Florida Administrative Code, and the applicant failed to demonstrate the qualifying agent would have the ability to supervise the construction work and business activities of the organization, as required by section 489.119, Florida Statutes, Rule 61G4-15.0024, Florida Administrative Code. Notice of Intent to Deny was filed in April of 2018. Mr. Garcia Mendez timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application.

LOFT, ERIK – REQUEST FOR INFORMAL HEARING

Mr. Loft was not present.

Ms. Clark presented this case stating Mr. Loft’s application for a Certified Sheet Metal Contractor’s license was denied at the March 2018 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2018. Mr. Loft timely requested board reconsideration.

After discussion, the board voted to uphold the denial.

PENA, SERGIO – REQUEST FOR INFORMAL HEARING

Mr. Pena was present.

Ms. Clark presented this case stating Mr. Pena’s application for a Certified Mechanical Contractor’s license was denied at the March 2018 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2018. Mr. Pena timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve a downgrade to a Class A Air Conditioning Contractor’s license.

PEREZ, GEORGE L. – REQUEST FOR INFORMAL HEARING

Mr. Perez was present.

Ms. Clark presented this case stating Mr. Perez’s application for a Certified General Contractor’s license was denied at the March 2018 meeting of the Board for failure to demonstrate the required

experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2018. Mr. Perez timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application.

WEAVER, STEVEN– PETITION FOR DECLARATORY STATEMENT

Mr. Weaver was not present.

Ms. Clark presented this case stating Mr. Weaver filed a petition for declaratory statement on April 2, 2018. The petition was noticed in the Florida Administrative Register on May 3, 2018. Ms. Clark noted the petition seeks the Board’s clarification of section 489.105(3), F.S., specifically whether certain license holders are allowed to provide construction management, in the context of Declaratory Statement DS 2011-082, and Chapters 471, 475, and 481, F.S.

After discussion, the board voted the petitioner has standing. After further discussion, the Board voted to deny the petition as it applies to past behavior, the Board does not have authority over the conduct of a third party, and the board does not have jurisdiction over Chapters 471, 475, and 481, F.S., nor the Florida Real Estate Commission, the Florida Board of Architecture and Interior Design, or the Florida Board of Engineering.

COMMITTEE REPORTS

ENDORSEMENT COMMITTEE – Aaron Boyette

Mr. Boyette informed the Board that during the June 11th conference call, the Endorsement Committee considered options available to endorsement applicants who have passed the examination administered by the National Association of State Contractor Licensing Agencies (“NASCLA”). Mr. Boyette stated that three motions were passed unanimously; the first motion is to require those candidates to pass the Florida Business Finance Test; the second motion was to require candidates to pass a Departmental examination related to the Florida Building Code; and the third motion was to refer draft language for Rule 61G4-15.004 to the Rules Committee for further development.
