PROSECUTING ATTORNEY'S REPORT – Ian Brown

Mr. Brown gave the following report:

For the month of April 2019, the overall license activity case load was 1535 down from 1543 in March of 2019, and up from 1035 in April of 2018.

There were 547 cases currently in Legal to be reviewed, 536 cases awaiting PC Panel/ Initial Review Completed, 99 cases set for probable cause, 58 cases where probable cause had been found/administrative complaints filed, 0 settlement stipulation approved, 36 informal hearings requested, 0 cases awaiting outside action, 35 cases ready for default, 129 formal hearings requested, 1 cases referred to DOAH, 6 cases in settlement negotiations, 0 case pending board date, 79 cases set for board presentation, 3 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of April 2019, 154 cases were closed.

Mr. Brown thanked Mr. Biggins for helping OGC with the wave of cases coming, and informed the board we are on the verge of 2,000 cases so far as a result of Hurricane Michael.

BACCI, ALFREDO – REQUEST FOR INFORMAL HEARING

Mr. Barnhart presented this case stating Mr. Bacci's application for a Certified Plumbing Contractor's license was denied at the November 2018 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in December of 2018. Mr. Bacci timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application.

The Notice of Intent to Deny was filed in February of 2019. Mr. Dusinberre timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application contingent.

FIRKUS, NICHOLAS – REQUEST FOR INFORMAL HEARING

Mr. Barnhart presented this case stating Mr. Firkus' application for a Certified Residential Contractor's license was denied at the February 2019 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida

Administrative Code and the applicant failed to sufficiently demonstrate financial stability and responsibility pursuant to section 489.115, F.S. and Rule 61G4-15.006, Florida Administrative Code. The Notice of Intent to Deny was filed in March of 2019. Mr. Firkus timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application.

LATHROP, ADRIENNE – PETITION FOR VARIANCE OR WAIVER

Ms. Lathrop was present.

Mr. Barnhart presented this case stating Ms. Lathrop filed a petition for Variance or Waiver on March 26, 2019. The petition was noticed in the Florida Administrative Register on March 29, 2019. Mr. Barnhart noted the Petitioner ask the Board for a variance or waiver of Rule 61G4-16.005, Florida Administrative Code.

After discussion, the board voted the petitioner had standing; after further discussion the board declined to answer, no hardship demonstrated.

MCLAUGHLIN, AMANDA – RECONSIDERATION

Ms. McLaughlin was not present.

Mr. Barnhart presented this case stating Ms. McLaughlin's application for a Certified Plumbing Contractor's license was denied at the November 2018 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in December of 2018. Ms. McLaughlin timely requested board reconsideration.

After discussion, the board voted to deny the request to vacate and withdraw the application and upheld the denial.

NAVARRO, GONZALO & CONRAD, ANDREA – PETITION FOR DECLARATORY STATEMENT

Counsel was present on behalf of petitioners.

Mr. Barnhart presented this case stating that the Mr. Navarro and Ms. Conrad filed a petition for Declaratory Statement on March 8, 2019. The petition was noticed in the Florida Administrative Register on March 22, 2019. The amended petition was filed with the Department of Business and Professional Regulation on April 17, 2019. Notice of the amended petition was published in the Florida Administrative Register on April 24, 2019. The petition to intervene filed by Sixsides Architecture, Inc was denied. The petition to Intervene filed by Florida Roofing and Sheet Metal Contractors Association was granted. Mr. Barnhart noted the petitioner asks the Board a few questions in regards to a dispute over whether a contract is valid or not.

1. Pursuant to section 489.113(2), F.S., does a person who is certified or registered "supervise" a subcontractor who is not certified or registered, when the person who is certified or registered never performs construction work other than procuring a building permit?

2. Pursuant to section 489.113(2), F.S., is a “supervising contractor” “responsible for the work” when the “supervising contractor” has no contract to perform work at the property?
3. Pursuant to section 489.103(16), F.S., if a certified or registered general contractor only obtains a building permit but does no construction work, were the contractor services to be performed under the terms of the design-build contract “rendered” by a certified or registered general contractor?
4. Pursuant to section 489.128, F.S., is SAI “unlicensed” to perform the construction work “rendered” by it?
5. Did section 489.103(16), F.S., exempt SAI from being licensed as a contractor, when the construction work was not rendered by the licensed contractor that procured the building permit?
6. Did section 489.103(16), F.S., when read together with section 481.229(3), F.S., exempt SAI from being licensed as a contractor, when the construction work was not negotiated by the licensed contractor that procured the building permit?
7. Did section 489.103(16), F.S., when read together with section 481.229(3), F.S., exempt SAI from being licensed as a contractor, when the construction work was not negotiated by any licensed contractor.

After discussion, the provisions of section 489.105(3)(c), F.S., are clear and the Board declines to answer the petition due to the Petitioners not having standing to request a Declaratory Statement from the Board. Even if the Petitioners have standing, the Board declines to answer the petition due to the following reasons: (1) conduct has already occurred; (2) asking about the conduct of another person; (3) litigation is either ongoing or imminent.

ROGERO, RICHARD – PETITION FOR VARIANCE OR WAIVER

Mr. Rogero was present with Counsel.

Mr. Barnhart presented this case stating Mr. Rogero filed a petition for Variance or Waiver on May 20, 2019. The petition was noticed in the Florida Administrative Register on May 23, 2019. Mr. Barnhart noted the Petitioner ask the Board for a variance or waiver of Rule 61G4-15.006 (1), Florida Administrative Code.

After discussion, the board voted the petitioner had standing; after further discussion the board voted to grant the petition for variance or waiver of Rule 61G4-15.006, Florida Administrative Code.

SANCHEZ JR., ANTONIO – REQUEST FOR INFORMAL HEARING

Mr. Sanchez was present.

Mr. Barnhart presented this case stating Mr. Sanchez’s application to qualify AR DESIGN AND CONSTRUCTION, LLC as an additional business was denied at the February 2019 meeting of the Board for failure to appear as required by Rule 61G4-15.0021, Florida Administrative Code, for failure to demonstrate the qualifying agent would have the ability to supervise the construction work and

business activities of the organization, as required by section 489.119, F.S. and Rule 61G4-15.0024, Florida Administrative Code and the applicant failed to sufficiently demonstrate financial stability and responsibility, pursuant to section 489.115, Florida Statutes and Rule 61G4-15.006, Florida Administrative Code. The Notice of Intent to Deny was filed in March of 2019. Mr. Sanchez timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application.
