## **RULES REPORT**

After a brief discussion regarding the proposed and existing percentages, the Committee voted to approve the proposed changes to 61G4-16.001.

The Committee voted that there would be no adverse impact on small businesses or small counties; that it will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after implementation; and that no part of the rule should be designated a minor violation. Further, the

Committee determined that this rule is mandated by statute and therefore no “sunset” provision would be included.

Ms. Wood inquired about the possibility of opening Chapter 61G4-18.001 for CE requirements at a future meeting. She would like to consider reallocation for adding hours to the Business Practice section.
