GENERAL SESSION

The meeting was called to order by Ms. Wood, at 9:00am. Mr. Feaster gave the Invocation. Mr. Strickland led the Pledge of Allegiance.

EXECUTIVE DIRECTOR'S REPORT – DANIEL BIGGINS

Mr. Biggins also reminded the Board about the CJIS training.

With nothing further to report the Board voted unanimously to approve this report.

CHAIRMAN'S REPORT – IAN BROWN

Ms. Wood, Vice-Chair, had nothing to report.

PETITIONS AND HEARING

ANICAMA, MARIO - PETITION FOR VARIANCE AND WAIVER

Mr. Anicama was present.

The Notice of Intent to Deny was filed in June of 2020. Mr. Blocker timely requested an informal hearing.

After discussion, the Board voted to vacate previous denial and approve the application contingent on the applicant providing proof of four years of being a W-2 employee for the years 2008-2012.

The Notice of Intent to Deny was filed in June of 2020. Mr. Moore timely requested an informal hearing.

After discussion, the Board voted to vacate previous denial and to approve the application.

OTTAVIANI, DAVID – INFORMAL HEARING

After discussion, the Board voted to vacate the previous denial and approve the application.
