NEW BUSINESS

Discussion took place regarding creating a rule that would define a “construction-related degree” pursuant to section 489.115, Florida Statutes, that would further clarify what degrees are acceptable for the 3.0 GPA exemption. After additional discussion, the Board voted unanimously to open rule 61G4-15.001, Florida Administrative Code, for further development. Mr. Shaw indicated that he would work with Mr. Dierlam to have language ready for presentation at the October 2022 board meeting.

The Board discussed the need for appointments and the issues with board members not attending the meeting but also not resigning their positions.
