The meeting was called to order by Rick Kane, at 9:30am. Mr. Thomason gave the Invocation. Mr. Evetts led the Pledge of Allegiance.

CHAIRMAN'S REPORT – Rick Kane

Mr. Kane spoke briefly about his attendance at the National Association of State Contractor Licensing Agencies annual conference in Nashville. Mr. Kane stated that one presentation about licensing boards having immunity from anti-trust violations specifically caught his attention, and he asked staff if they could obtain a video of that presentation to be distributed to board members.

PROSECUTING ATTORNEY'S REPORT – Ian Brown

Mr. Brown gave the following report:

For the month of July 2018, the overall license activity case load was 1160, down from 1174 in June of 2018, and up from 859 in June 2017.

There were 323 cases currently in Legal to be reviewed, 543 cases awaiting PC Panel/ Initial Review Completed, 3 cases set for probable cause, 37 cases where probable cause had been found/administrative complaints filed, 2 settlement stipulation approved, 3 informal hearings requested, 0 cases awaiting outside action, 20 cases ready for default, 129 formal hearings requested, 2 cases referred to DOAH, 14 cases in settlement negotiations, 0 case pending board date, 70 cases set for board presentation, 2 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of July 2018, 134 cases were closed; this included 33 Final Orders with Discipline.
