**GENERAL SESSION**

The meeting was called to order by Ms. Wood, at 8:30am. Mr. Cawthon gave the Invocation. Mr. McCullers led the Pledge of Allegiance.

**EXECUTIVE DIRECTOR’S REPORT – Donald Shaw**

Mr. Shaw welcomed the two new board members Ashley Ross and Brian “Parks” Wilson to the Board.

Mr. Shaw welcomed the new Recovery Fund team lead Angelica Barnes to the team.

Mr. Shaw requested the Board excuse absences for the following board members:

Mr. Shaw thanked all of the Board Members who wrote letters of recommendation to the Secretary of the Department recommending him for the position of Executive Director and also

thanked previous Executive Director Daniel Biggins for his many years of mentorship and guidance.

With nothing further to report the Board voted unanimously to approve this report.

#### **PROSECUTING ATTORNEY'S REPORT- Ian Brown**

Mr. Brown provided personnel updates for his section. Mr. Brown also congratulated Mr. Shaw on his promotion to Executive Director.

Mr. Brown also welcomed Ms. Ross and Mr. Wilson.

#### **CHAIRMAN'S REPORT - Rachelle Wood**

Ms. Wood spoke about changes to the upcoming ICC code changes.

Ms. Wood welcomed Ms. Ross and Mr. Wilson to the Board.

Ms. Wood also recognized previous Executive Director Dan Biggins and commended the job that he had done over the years and requested a round of applause be given to Mr. Biggins.

#### **HEARING AND PETITIONS**

##### **BROWN, ROBERT – INFORMAL HEARING**

Mr. Milne presented this case stating Mr. Brown's application to qualify Coastal Plumbing, Inc., as an additional business entity was denied at the July 2021 meeting of the Board for failure to appear as required by Rule 61G4-15.0021, Florida Administrative Code, and for failure to demonstrate supervision as required by section 489.119, Florida Statutes, and Rule 61G4-15.0024, Florida Administrative Code. The Notice of Intent to deny was filed in August of 2021. Mr. Brown timely requested an informal hearing.

After discussion the Board voted to vacate the previous denial and to approve the application contingent on the applicant providing proof of 20% ownership in the proposed entity within 30 days.

##### **CABALLERO, LUIS – INFORMAL HEARING**

Mr. Milne presented this case stating Mr. Caballero's application to qualify Casin Services and Repair, Inc., was approved at the July 2021 meeting of the Board, contingent on the applicant providing proof of 20% ownership in the company. The Notice of Intent to Approve with Conditions was filed in August of 2021. Mr. Caballero timely requested an informal hearing,

requesting that the Board allow him to withdraw the application as he was unable to secure the required ownership percentage in the company.

Mr. Milne presented this case stating that the City of Parkland Building Department filed a petition for a declaratory statement on August 18, 2021. The petition was noticed in the Florida Administrative Register on August 20, 2021. Mr. Milne noted the petitioner is seeking clarification on section 489.105 (3)(o), Florida Statutes, and asks if a certified plumbing contractor has the authority to install pool equipment.

After discussion the Board voted to deny the petition stating that the provisions of section 489.105 (3)(o), Florida Statutes, are clear and do not need further interpretation.

### **DEPRIEST, TROY – INFORMAL HEARING**

Mr. Milne presented this case stating Mr. DePriest's application for a Certified General Contractor's license was denied at the August 2021 meeting of the Board for failure to comply with the requirements of section 489.115 (3)(d), Florida Statutes. After discussion the Board voted to uphold the previous denial.

The Notice of Intent to Deny was filed in September of 2021. Mr. Gonzalez timely requested an informal hearing.

After discussion the Board voted to uphold the previous denial.

The Notice of Intent to Deny was filed in August of 2021. Mr. Kraja timely requested an informal hearing.

After discussion the Board voted to uphold the previous denial.

### **LAMONACO, JOSE – MOTION TO RECONSIDER**

Mr. Lamonaco was present with Counsel.

Mr. Milne presented this case stating Mr. Lamonaco's application to change his Certified Air Conditioning Contractor's license from inactive to active was originally denied at the September 2020 meeting for failure to comply with a previously entered order for case 2010039100 and because the applicant was under investigation or prosecution for an action that would constitute a violation of the practice act. The Notice of Intent to Deny was filed in October 2020. Mr. Lamonaco timely requested an informal hearing, which was heard at the February 2021 meeting. At that meeting, the Board voted to uphold the previous denial and the Final Order Upholding the Notice of Intent to Deny was filed in April of 2021. Mr. Lamonaco then filed a Request for Reconsideration, which was filed in August of 2021.

After discussion, the Board voted to vacate the previously entered Final Order and Notice of Intent to Deny, and voted to approve the application with the following conditions:

- Applicant must complete a 7-hour Laws & Rules course within 30 days.
- Applicant must complete a 7-hour Financial Management course within 30 days.
- Applicant must pay all outstanding fines and costs within 30 days.
- Applicant is to serve 5 years of probation and shall pay off all interest for the fines over the 5-year period of probation.

#### **NEWMAN, KYLE – INFORMAL HEARING**

After discussion the Board voted to uphold the previous denial.

#### **RIFAI, MICHAEL – INFORMAL HEARING**

Mr. Milne presented this case stating that Mr. Rifai's application to qualify Venture Homes of Florida, LLC as an additional business entity was denied at the August 2021 meeting of the Board for failure to appear as required by Rule 61G4-15.0021, Florida Administrative Code, and for failure to demonstrate supervision as required by section 489.119, Florida Statutes, and Rule 61G4-15.0024, Florida Administrative Code. The Notice of Intent to Deny was filed in August of 2021. Mr. Rifai's timely requested an informal hearing.

After discussion the Board voted to vacate the previous denial and to approve the application.

#### **RYAN, MICHAEL – INFORMAL HEARING**

Mr. Milne presented this case stating Mr. Ryan's application for a Certified Roofing Contractor's License was approved at the June 2021 meeting of the Board, contingent on providing proof of 3 years' worth of W2 employment to verify his experience within 60 days, and to complete a 7-hour course on Laws & Rules within 60 days. The Notice of Intent to Approve with Conditions was filed in July 2021. Mr. Ryan timely requested an informal hearing to allow him to withdraw the application as he was unable to provide the required documentation.
