## **MARK HICKINBOTHAM – PETITION FOR DECLARATORY STATEMENT**

Mr. Dolan presented this case stating that Mr. Hickinbotham filed a petition for Declaratory Statement on September 21, 2015. The petition was noticed in the Florida Administrative Register on October 22, 2015. Mr. Dolan noted the petitioner asks the Board whether the work to install the duct, tube or conduit for conveying air as described in the petition is considered ductwork, whether installing ductwork that is not part of an interior HVAC system as described in subsection 61G4-12.011(14), F.A.C., requires a licensed Florida contractor, whether the work to furnish and install ductwork on the jobsite as described in the petition can be performed with a class A or B HVAC contractor's license, whether the work to furnish and install ductwork on the jobsite be performed with a mechanical contractor's license, and whether a General Contractor must subcontract the ductwork.

After discussion, the board voted to decline to answer due to the petition not relating to a particular set of circumstances, and because the questions posed are answered in the statute and do not require a declaratory statement as to applicability.

### **MARK HICKINBOTHAM – PETITION FOR DECLARATORY STATEMENT**

Mr. Hickinbotham was present.

Mr. Dolan presented this case stating that Mr. Hickinbotham filed a petition for Declaratory Statement on September 21, 2015. After discussion, the board voted to decline to answer due to the questions posed are answered in statutes and do not require a declaratory statement as to applicability.

### **MARK HICKINBOTHAM – PETITION FOR DECLARATORY STATEMENT**

Mr. Hickinbotham was present.

Mr. Dolan presented this case stating that Mr. Hickinbotham filed a petition for Declaratory Statement on September 21, 2015. The petition was noticed in the Florida Administrative Register on October 22, 2015. Mr. Dolan noted the petitioner asks the Board whether the temporary sewage piping work as described in the petition is considered part of the "Main Sanitary Sewer Collection System" as defined in subsection 61G4-12.011(4), F.A.C., whether the work to furnish and install above or below ground temporary sewage piping onsite as described in the petition has to be performed by a Florida licensed contractor, whether the work to furnish and install temporary sewage piping onsite as described in the petition can be performed by a Florida licensed plumbing contractor, an underground utility and excavation contractor, or a general contractor, and whether sewer systems described in the petition exempt from licensing under 489.103(6), F.S.

After discussion, the board voted to decline to answer due to the questions posed are answered in statutes and do not require a declaratory statement as to applicability.
