The meeting was called to order by Chris Cobb, at 8:31am. Mr. Lenois gave the Invocation. Mr. Laney led the Pledge of Allegiance.

**EXECUTIVE DIRECTOR'S REPORT – Daniel Biggins**

Mr. Biggins thanked the board, staff and attorneys for helping us get through the setbacks of Hurricane Irma.

With nothing further to report the board voted unanimously to approve this report.

**CHAIRMAN'S REPORT – Chris Cobb**

Mr. Cobb thanked Mr. Lenois and Mr. Allocco for their time of service on the Board.

Mr. Cobb also thanked everyone for allowing him to serve as Board Chair over the past year.

With nothing further to report the board voted unanimously to approve this report.

**PROSECUTING ATTORNEY'S REPORT – Ian Brown**

Mr. Brown gave the following report:

For the month of September 2017, the overall license activity case load was 732, down from 829 in August of 2017, and down from 931 in September 2016.

There were 346 cases currently in Legal to be reviewed, 167 cases awaiting PC Panel/ Initial Review Completed, 18 cases set for probable cause, 16 cases where probable cause had been found/administrative complaints filed, 0 settlement stipulation approved, 7 informal hearings requested, 0 cases awaiting outside action, 32 cases ready for default, 70 formal hearings requested, 1 case referred to DOAH, 14 cases in settlement negotiations, 0 case pending board date, 60 cases set for

board presentation, 1 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of September 2017, 171 cases were closed; this included 18 Final Orders with Discipline.

**ATTORNEY GENERAL’S REPORT – Rachel Clark**
