REVIEW OF MINUTES

• Final Action – February, 2006

The Board voted unanimously to approve these minutes.

EXECUTIVE DIRECTOR'S REPORT

Mr. Vaccaro announced that he accepted a promotion and would be the new Division of Professions' Director. The Board Members expressed their joy in his promotion and stated that they would miss him as their Executive Director.

CHAIRMAN'S REPORT

Mr. Brown stated that Mr. Kalmanson's absence was excused. She also stated that Mr. Thornton's absence for General Session was excused.

PROSECUTING ATTORNEY'S REPORT

Ratification of Local Disciplinary Orders List

The Board voted unanimously to approve this list.

Mr. Creehan gave the following report:

As of February, there were 510 cases in Legal (to be reviewed), there were 219 cases set for probable cause, 165 cases has Probable Cause found/Administrative Complaints filed and 56 cases were ready for default. There were 33 cases with Stipulations executed/Informal Hearing requested, 111 cases that had requested Formal Hearings, 12 cases were referred to DOAH, 70 cases were awaiting Final Orders and 9 cases were trying to reach Settlement Negotiations. There were also 3 cases that were re-opened and 3 cases set for Board Presentation. For the month of February 2006, 60 cases were closed.
