General Session was called to order at 8:33 am. Mr. Stewart gave the invocation. Mr. Flaherty led the Pledge of Allegiance.

REVIEW OF MINUTES

The board voted unanimously to approve the following minutes:

EXECUTIVE DIRECTOR'S REPORT – G.W. HARRELL

Mr. Harrell gave the following report:

Mr. Harrell asked the board members if they've liked the OnBase experiment so far and that he was real happy with the progress staff has made in converting to a paperless agenda.

Mr. Harrell stated that he recently addressed the Building Official Association of Florida regarding the definition of "supervision" according to the Rule. The problem of inspectors going to the job and essentially supervising workers to make sure work was code compliant was also discussed. Another issue discussed with the Building Official Association was the discipline of certified contractors by local jurisdictions.

Mr. Harrell also brought up the issue of the Department is not assessing the costs of administering the exams, so that people who are taking the exams before they apply are, essentially, not paying for their exams. Steps are being taken by the Department to remedy this problem. A motion was made and seconded to open Rule 61G4-12.009 for further review. The board voted unanimously to open the Rule.

Mr. Harrell also thanked Chair Raymond Holloway for his service as Chairman for the past year.

With nothing further to report the board voted unanimously to approve this report.

CHAIRMAN'S REPORT – RAYMOND HOLLOWAY

The Chairman had nothing to report this month.

PROSECUTING ATTORNEY'S REPORT – JEFF KELLY

Mr. Kelly gave the following report:

For the month of May 2008 the overall case load in Legal was 2,213, down from 2,315 in April 2008 and up from 1,671 in May 2007.

The total number of cases waiting to be reviewed was 644. There were 265 cases set for probable cause, 441 cases where probable cause had been found/administrative complaints filed, 24 cases with stipulations executed/informal hearings requested, and 176 cases had requested formal hearings. 129 cases where ready for default, 103

cases were referred to DOAH, and 123 cases were in settlement negotiations. 171 cases were set for board presentation, and 137 cases were awaiting final orders. 0 cases were under appeal and 0 cases had been reopened.

The board voted unanimously to accept the local discipline against the following registered contractors:

John Allen Gage, RR0060430 – 2008019370 – Revocation, \$15,000 fine, \$2,900 in costs to Hernando County

Mr. Kelly also requested the board to make a motion to vacate two orders for two cases that were heard in Final Action the day prior, and to grant the respondent a 30 day continuance. The board voted unanimously to vacate those order and grant the continuance.

With nothing further to report the board voted unanimously to approve this report.

RECOVERY FUND ATTORNEY'S REPORT – MARC DREXLER

Mr. Drexler gave the following report:

The Recovery Fund started the year with an appropriation of \$3.25 million. As of May 31st the total amount of money disbursed was \$1,941,867.16 with another \$768,235.40 obligated, leaving a cash balance of \$539,897.81.

468 claims are currently pending, 33 of those which are Division II. 315 new claims had been received that year, with 165 of those being ineligible. During May, 61 new claims were received of which 44 were ineligible. 0 claims had been recommended for denial and 20 were set for Committee review. 304 claims over 180 days were incomplete, 164 claims were incomplete under 180 days. 5 claims were currently under appeal.

With nothing further to report the board voted unanimously to approve this report.

ATTORNEY GENERAL'S REPORT – DAN BIGGINS/WILLIAM OGLO

YANUARIO ARIAS – MOTION FOR RECONSIDERATION

Mr. Arias was present.

Mr. Biggins presented this case stating Mr. Arias' application for initial licensure as a certified building contractor through grandfathering was denied at the June 2005 meeting of the board for failing to provide proof of his civil rights having been restored. The Notice of Intent to Deny was filed in June of 2005. Mr. Arias then filed a "Petition To De Nova Review/Appeal Decision and Rule". The board affirmed their decision and the Final Order was filed in November of 2005. Mr. Arias then filed a Motion for Reconsideration.

After discussion the board voted unanimously to uphold the denial.

CONTINUING EDUCATION ASSOCIATES, INC. – REQUEST FOR INFORMAL HEARING

A representative from Continuing Education Associates, Inc. was not present.

Mr. Biggins presented this case stating the Continuing Education Associates continuing education course was denied at the April 2008 meeting of the board as the course materials failed to be sufficiently descriptive of the course. The Notice of Intent to Deny was filed in June of 2008. Continuing Education Associates, Inc. timely requested board reconsideration.

After discussion the board voted to uphold the denial.

CONTRACTOR EDUCATION SYSTEMS, INC. – REQUEST FOR INFORMAL HEARING

A representative from Contractor Education Systems, Inc. was present.

Mr. Biggins presented this case stating Contractor Education Systems, Inc.'s application for continuing education courses entitled, "Advanced Rules and Laws for Florida Contractors – Online Course", "Contractors Comprehensive Continuing Education Seminar – Course A5RL", "Contractors Comprehensive Online Continuing Education Course B5RL-OL", were denied for the laws and rules credit as the course materials failed to sufficiently detail instruction in that area. The Notice of Intent to Deny as filed in June of 2008. Contractor Education Systems, Inc. timely requested board reconsideration.

After discussion the board voted unanimously to approve the application.

JAMES KELLY – REQUEST FOR REINSTATEMENT OF PROBATION

Mr. Kelly was present.

Mr. Biggins presented this case as a request by Mr. Kelly to reinstate the stay of suspension on his certified general contractor's license. The stay of suspension was lifted on January 22, 2008 for failing to appear at his scheduled probation appearance. The request to reinstate the stay was filed in May of 2008.

After discussion the board voted unanimously to reinstate the stay of suspension with one unsatisfactory appearance on his record and a \$200 citation.

LAWRENCE LAMBECK – REQUEST FOR INFORMAL HEARING

Mr. Lambeck withdrew his request for an informal hearing.

THOMAS A. LEE – REQUEST FOR INFORMAL HEARING

A representative from Thomas A. Lee was not present.

Mr. Biggins presented this case stating Thomas A. Lee's continuing education course application was denied at the January 2008 meeting of the board for failure to sufficiently detail contact information and the method of time tracking. The Notice of Intent to Deny was filed in May of 2008. Thomas A. Lee timely requested board reconsideration.

After discussion the board voted to send the application back to the CE Committee for further review.

MICHAEL MURRAY – REQUEST FOR INFORMAL HEARING

Mr. Murray was present.

Mr. Biggins presented this case stating Mr. Murray's change of status application to move his certified general contractor's license from one business entity to another was denied at the January 2008 meeting of the board because the applicant was the subject of pending discipline. As a result, the qualified business license for AMS, Inc. was denied for failing to have a qualifying agent. The Notices of Intent to Deny were filed in May of 2008. Mr. Murray timely requested board reconsideration.

After discussion the board voted unanimously to approve the application.

ROBERT H. RAINES – REQUEST FOR INFORMAL HEARING

Mr. Raines was present.

Mr. Biggins presented this case stating Mr. Raines' application for initial licensure as a certified residential contractor was denied at the October 2007 meeting of the board for failing to demonstrate the required experience, for having been convicted, or found guilty, of a crime related to the practice of contracting, and for failing to provide proof of good moral character. The Notice of Intent to Deny was filed in March of 2008. Mr. Raines timely requested board reconsideration.

After discussion Mr. Raines withdrew his request for an informal hearing stating he would prefer to appear in front of an Administrative Law Judge with DOAH.

With nothing further report the board voted unanimously to approve this report.

NEW BUSINESS

Mr. Del Vecchio brought up the issue of a law firm that assists the Department's prosecuting attorney's also appears to be assisting applicants obtain initial licensure. Mr. Del Vecchio stated that it seems to him to be an inherent conflict of interest. Ms. Hammonds stated that the state legislature, after the bad hurricane seasons of the previous years, appropriated money in the budget to hire outside counsel to assist with prosecutions, and the only stipulation in the contract was that any prosecutorial cases the firm was currently working had to be abandoned by the firm. Mr. Harrell explained the situation that, because of the hurricanes, the construction case load doubled. The legislature decided that instead of letting the cases just sit there, and instead of creating

more full time positions within the Department, to hire outside counsel to assist. Board members expressed displeasure with this state of affairs.

Ms. Watts brought up the issue that she's tired of seeing vehicle signage indicating an individual is licensed and insured when all that the individual is in possession of is an occupational license. Ms. Watts stated the board needs to address and attempt to solve this problem. Ms. Brown voiced her concerns over this issue as well, and how some unlicensed contractors honestly believe that the occupational license will allow them to perform regulated activities.

Mr. Kalmanson also requested an excused absence for the meeting next month. The board voted unanimously to approve this absence.
