Petition for Declaratory Statement, Deborah Loucks, Esq., Senior Assistant Attorney General

Petition for Declaratory State from Crystal Barker King – Clear VOIP Solutions

Ms. King and Mr. King were present and sworn in.

Ms. King asks whether telecommunications companies governed under Chapter 364, FS, remain exempt from electrical contracting licensure, notwithstanding the repeal of the formal certification requirement; and seeks confirmation that DBPR recognizes that telecommunications providers operating under the Telecommunications Act of 1996 and the FCC's Vonage order are federally regulated and thereby exempt from state or local electrical licensing or permitting requirements for low-voltage telecommunications infrastructure. The Board declined to answer the petition. The Board stated that the exemption set forth in Section 489.503(14), Florida Statutes, was clear as to what requirements must be met to qualify for the exemption. As to the second question, the Board stated that it neither has the authority to provide statements on behalf of the DBPR nor does it have jurisdiction over local permitting or licensing requirements.
