Minutes of THE FLORIDA REAL ESTATE COMMISSION March 11 and 12, 2014 General Meeting

Vice-Chair Poul Hornsleth, called the meeting of the Florida Real Estate Commission to order, at approximately 8:30 a.m., in Orlando, Florida, on this 11th day of March, 2014.

Tab BC – Amy Vandiver – not present – Commissioner Furst moved; seconded by Commissioner Podolsky to deny the application for sales associate; the motion passed without dissent.

Tab BF – Ricco Wilkerson – not present – Commissioner Podolsky moved; seconded by Commissioner Fryer to approve the application for sales associate; tie vote 3 to 3. No action taken.

Tab BG – Tatiana Young – not present – Commissioner Furst moved; seconded by Commissioner Podolsky to deny the application for sales associate; the motion passed without dissent.

Director's Comments

Director Watkins provided the following comments:

- > Reported that Commissioner's Furst's appointment was confirmed by the Legislature.
- > The Division has begun the planning process of its conference/meeting room, which includes replacing the recording system and microphones.
- Examination/Education Director Watkins responded to the Commission's inquiry, during yesterday's session, of why the pass rate has been improving. Director Watkins reported that the Bureau of Education and Testing (BET) has added an instructor's email blast box to its website and emails are being sent on a regular basis to any instructor or school who signs up to receive them. Director Watkins explained that perhaps it is attributed to the email blasts BET has been sending to instructors and school owners which includes statistical information as well as information that BET has identified as underperforming item topics to help the instructors and school owners see where students may need to improve in terms of their studying.
- ➤ House Bill 1319 is currently the only bill that she is aware of that may impact the Real Estate Commission directly. This bill attempts to possibly address the exemption under short-term rentals by redefining the definition of broker to include short-term property managers. However, she reported that there is no companion Senate bill, so it appears that there is no momentum to move forward with the language. Director Watkins reported that she will continue to monitor this and will keep the Commissioners apprised of the status of this bill. Director Watkins addressed questions from the Commission.

Commission's Remarks

Vice-Chair Hornsleth reported that he attended the Chair and Vice-Chair Leadership Symposium and reported that it was very interesting.

Commissioner Furst reported that Ms. Marie Powell, who was a former Commissioner and past FREC Chair, passed away last week and asked that the Department send their condolences to Ms. Powell's family.

Public Comments

The Commission invited but did not receive comments from the audience.

Adjournment

There being no further business and no objection, the Vice-Chair adjourned the meeting at approximately 2:10 p.m. The next general meeting of the Florida Real Estate Commission is scheduled for April 15 and 16, 2014, in Orlando, Florida.
