Minutes of THE FLORIDA REAL ESTATE COMMISSION May 19 and 20, 2015 General Meeting

Chair Darla Furst, called the meeting of the Florida Real Estate Commission to order, at approximately 8:35 a.m., in Orlando, Florida, on this 19th day of May, 2015.

The following Commission members were in attendance: Chair Darla Furst, Vice-Chair Dick Fryer, Chip Boring, Lee Chotas, Poul Hornsleth and Thomas Luzier. Commissioner Enzor had an excused absence. Mr. Tom Barnhart, Senior Assistant Attorney General, appeared as counsel for the Commission. Mr. Barnhart declared a quorum present.

Approval of the Minutes

Vice-Chair Fryer moved to approve the Minutes of the April 14 and 15, 2015, General Meeting, as written. Commissioner Luzier seconded the motion. The motion passed without dissent.

Reports

Enforcement Trends and Escrow Audits Reports

Bureau Chief Sara Kimmig presented the report regarding Enforcement Trends and Escrow Audits Summary and addressed questions and comments from the Commission.

Unlicensed Activity Report

Bureau Chief Sara Kimmig presented the Unlicensed Activity Report and addressed questions from the Commission.

Monthly Exam Performance Summary Report

Director Watkins presented the monthly Exam Performance Summary Report and addressed questions and comments from the Commission.

Director Watkins reported that the work of the taskforce review of broker syllabus workshop concluded yesterday and thank everyone who participated. Vice-Chair Fryer thanked Mr. Frank Gregoire for assisting

with the appraisal section of the broker syllabus and commented that it was truly an undertaking. Chair Furst thanked Vice-Chair Fryer for graciously accepting the task of chairing the taskforce. A draft of the broker syllabus will be set for the agenda in June, 2015.

Financial Reports

Director Watkins presented the Financial Reports ending March 31, 2015, and addressed questions and comments from the Commission.

Chair Furst inquired as to when the Legislature will sweep the general funds and requested a report which reflects a 4-year accounting of how much has been swept. Director Watkins stated that the Division will make that request.

Quarterly Education and Foundation Scholarship Report

Deputy Director Johnson presented the third quarter Education Foundation Scholarship report and provided a brief summary of the progress during this quarter.

Application and License Count Reports

Deputy Director Johnson presented the Application and License Count Report and addressed questions and comments from the Commission.

Special Agenda

Paperless Licensing

Director Watkins reported that a few months ago we explained that it was the department's desire to transition to a paperless license system beginning with real estate. Ms. Watkins stated that Deputy Secretary Tim Vaccaro and Director George Ayrish, Division of Service Operations wanted to provide an update of the progress. Mr. Ayrish provided a brief presentation informing the Commission of the progress of the paperless licensing and provided a PowerPoint reflecting the steps a licensee would take to print their own license. Mr. Ayrish informed that the Department will initiate the process on June 4, 2015. Mr. Ayrish addressed questions and comments from the Commission. The Commission thanked Mr. Ayrish and Deputy Secretary Vaccaro for their presentation and commented that this is a great step forward.

The Commission entered into discussion. Commissioner Hornsleth moved to accept 13 Escrow Disbursement Orders, 1 Order Vacating the Previous EDO and 5 Orders as recommended. Commissioner Chotas seconded the motion; the motion passed without dissent.

Tab Z – How To Build A Successful New Homes Niche – New Course (3 hours Specialty CE; Distance) – Application No. 23179 – David R. Fletcher

Mr. Fletcher appeared in support of the application. The Commission entered into discussion. Vice-Chair Fryer moved to deny the course for 4 hours of Specialty CE; Commissioner Luzier seconded the motion. The motion passed without dissent.

Special Agenda

Proposed Revisions to Chapter 475 and FREC Administrative Rules Regarding Pre-licensing received from Linda Crawford

Ms. Linda Crawford of Dearborn presented proposed revisions to Chapter 475 and FREC Administrative Rules regarding pre-licensing for the Commission to consider for the upcoming Legislative Session scheduled for January 2016. Ms. Crawford provided a brief summary supporting her suggestions which includes:

- 1. Requiring the applicant repeat the 63-hour pre-license and again pass the end-of-course exam course after three failed attempts prior to taking the exam a fourth time.
- 2. Schools and their instructors may not give students a copy of the end-of-course exam prior to testing.
- 3. Schools may prepare and provide students with a study guide for the purpose of preparing for the end-of-course exam.
- 4. After two 2-year course renewals, pre license course content and end-of-course exams must be re-submitted for course evaluation so that on approximately year 5, pre licenses courses are evaluated by the DBPR to confirm that the course conforms to the Commission approved course syllabus, and that the course is current with regards to content, statutes, and rules.
- 5. Schools may not advertise their end-of-course exam pass rate; and Schools may not advertise their school's pass rate on the license exam.

The Commission thanked Ms. Crawford for her submission. The Commission requested to bring this topic back in June to provide other educators an opportunity to provide suggestions and comments in response to Ms. Crawford's submission or provide additional suggestions relating to this topic.

Rules Report

FREC Counsel Barnhart reported on the status of the rules currently open for discussion, workshop or rulemaking and addressed questions and comments from the Commission.

Proposed Rule Workshop

Rule 61J2-1.011 – Fees

Mr. Barnhart presented this matter to the Commission to request opening this rule for development. Ms. Watkins reported that the fee associated with duplicate licensing needs to be deleted once the paperless licensing initiative is put into production. The Commissioner entered into discussion and authorized Mr. Barnhart to advertise the rule with the deletion of the duplicate license fee. The Commission will have a copy of the rule with the amendment and the Statement of Estimated Regulatory Costs for final review next month.

61J2-3.008 - Pre-licensing Education for Broker and Sales Associate Applicants

Director Watkins presented this rule for the Commission's review and explained that this rule requires amendments to address the effective dates of the syllabi; to amend the term "salesperson" to reflect "sales associate" in Section 3.008(8); and to bring the rule into compliance with the statutory changes relating to Section 3.008(9). FREC Counsel Barnhart stated that a draft of the rule together with the Statement of Estimated Regulatory Cost checklist will be set for the June 2015 agenda for consideration and final approval.

61J2-3.009 - Continuing Education for Active and Inactive Broker and Sales Associate Licensees

Director Watkins presented this rule for the Commission's review and explained that this rule requires amendments to bring the rule into compliance with the statutory changes relating to Section 3.009(1)(b). FREC Counsel Barnhart stated that a draft of the rule together with the Statement of Estimated Regulatory Cost checklist will be set for the June 2015 agenda for consideration and final approval.

Annual Regulatory Plan and Rules Review for 61J2, Florida Administrative Code

Director Watkins reported that the Biennial Rules Review is due by July 1, 2015, and requested that the Commission review 61J2 for the June meeting for any possible changes they would like to recommend. FREC Counsel Barnhart reported that the 2015-2016 Annual Regulatory Plan is due October 1, 2015, explained that the plan submitted to the Governor's Office OFFAR provides a preview of rules which may be reviewed by the Commission during the 2015-2016 Fiscal Year. However, since the Rule Review and the Regulatory Plan go hand-in-hand it would be ideal to complete a preliminary draft of the Regulatory Plan at the same time. Mr. Barnhart explained that this is a preliminary list and other rules may be included if necessary. Ms. Watkins stated that the Rules Review will be scheduled for June, 2015.

Legislative proposals

Director Watkins requested the Commissioners to provide topics or proposal they would like to have for the upcoming Legislative Session beginning January 1, 2016, which is just around the corner.

Ms. Watkins reported that as a result of the recent Legislative session changes were made to the following Statutes: Section 475.15, Florida Statutes – Vacancies; Section 475.17(6) – Qualifications for practice; and Section 475.183 – Inactive status. Ms. Watkins explained that the changes provided the Commission with rule making authority and requested that the Commissioners review the associated rules for issues they would like to address.

Additionally, Ms. Watkins requested that the Commissioners relay to her any issues they would like to propose or send her an email with any suggestions as soon as possible as the proposals are due very soon for the January 2016 Legislative Session.
