**Minutes of
THE FLORIDA REAL ESTATE COMMISSION
June 22 and 23, 2010
General Meeting**

Chair Roger Enzor called the meeting of the Florida Real Estate Commission to order, at approximately 8:30 a.m., in Orlando, Florida, on this 22nd day of June, 2010.

The following Commission members were in attendance: Chair Roger Enzor, Vice-Chair Richard DeNapoli; Claude "Chip" Boring, Darla Furst, Ralph McCoig, and John Ruffier. Commission Guju was excused. Tom Barnhart, Senior Assistant Attorney General, appeared as counsel for the Commission. Mr. Barnhart declared a quorum present.

Division staff present at the meeting: Thomas O'Bryant, Jr., Director and Executive Director; James Harwood, Chief Attorney; Brad Koshland, Bureau Chief of Enforcement; Jennifer Blakeman, Patrick Cunningham, Robert Minarcin, Joseph Solla, Senior Attorneys; JoEllen Peacock, Education Coordinator; Jocelyn Pomales, Regulatory Specialist III; Lori Crawford, Regulatory Supervisor/Consultant. American Court Reporting, Inc. (407) 896-1813 provided court reporter services.

Approval of the Minutes

Commissioner Ruffier moved; Commissioner Boring seconded to approve the Minutes of the May 18 and 19, 2010, General Meeting, as written. Motion carried unanimously.

Report Regarding Complaints Over 365 Days

Director O'Bryant presented the report regarding Complaints Over 365 Days. Director O'Bryant addressed questions from the Commission.

Unlicensed Activity Report

Director O'Bryant presented the Unlicensed Activity Report. Director O'Bryant addressed questions from the Commission.

Broker Examination Update Timeline

Director O'Bryant presented the Broker Examination Update Timeline. Director O'Bryant addressed questions from the Commission and the audience.

Escrow Disbursement Orders

Attorney Joseph Solla presented 31 Escrow Disbursement Orders and 3 Orders to interplead for the Commission's consideration. Mr. Solla reported that items L and AF have been settled and withdrawn from consideration. Upon recommendation of the Legal Section, the Commission issued 29 Escrow Disbursement Orders and 3 Orders. Commissioner McCoig moved to approve the Legal Section recommendation. Vice-Chair DeNapoli seconded the motion. The motion carried unanimously.

Recovery Fund Claim Final Order

Christine Sundquist v. Bill Unsworth – DBPR Case No. 2009012179. Senior Attorney Solla presented this matter to the Commission. Respondent Unsworth was not present. Claimant Christine Sundquist appeared and presented mitigation in support of her claim. Mr. Solla advised that the claimant does not qualify statutorily to receive payment from the recovery fund and recommended the Commission deny the request. The Commission considered the facts and circumstances. Vice-Chair DeNapoli moved to approve the order denying the claim. Commissioner Furst seconded the motion. The motion carried unanimously. The motion carried unanimously.

DOAH Recommended Orders - Applicants

Alvah T. Wickboldt v. DBPR, Florida Real Estate Commission – DOAH Case No. 09-4030

FREC Counsel Tom Barnhart presented the Recommended Order of the Administrative Law Judge. Petitioner was not present. The Commission considered the Recommended Order of the Division of Administrative Hearings recommending the Petitioner's application for licensure as a real estate sales associate be denied. Director O'Bryant stated that a division investigator requesting guidance relating to commission loss checks being paid by British Petroleum that are written directly to the sales associate and not to the brokerage. Mr. Barnhart stated that when the sales associates file a claim they should request that the checks be made payable to the brokerage and if the check is not made payable to the brokerage the sales associate must turn the check into the brokerage. The Commission's opinion is that the checks should be made payable to the brokerage as required by Section 475.42(1)(d), Florida Statutes.

61J2-2.027 – Applications by Individuals
