# Minutes of THE FLORIDA REAL ESTATE COMMISSION November 18 and 19, 2014 General Meeting

Chair Darla Furst, called the meeting of the Florida Real Estate Commission to order, at approximately 8:35 a.m., in Orlando, Florida, on this 18<sup>th</sup> day of November, 2014.

The following Commission members were in attendance: Chair Darla Furst, Vice-Chair Dick Fryer, Chip Boring, Lee Chotas, Poul Hornsleth and Josh Podolsky. Commissioner Enzor had an excused absence. Mr. Tom Barnhart, Senior Assistant Attorney General, appeared as counsel for the Commission. Mr. Barnhart declared a quorum present.

Commissioner Furst moved; seconded by Commissioner Fryer to approve the Minutes of the October 14 and 15, 2014, General Meeting, as written. The motion passed without dissent.

Director Watkins presented the report regarding Enforcement Trends and Escrow Audits Summary and addressed questions and comments from the Commission.

#### **Unlicensed Activity Report**

Director Watkins presented the Unlicensed Activity Report and addressed questions from the Commission.

#### Monthly Exam Performance Summary Report

Director Watkins presented the monthly Exam Performance Summary Report and addressed questions and comments from the Commission.

#### Quarterly Education and Foundation Scholarship Report

Deputy Director Johnson presented the first quarter Education Foundation Scholarship report and provided a brief summary of the progress during this quarter. Vice-Chair Fryer reported that this is his last year on the Scholarship Committee and that he is in the process of evaluating the applications that he has received. Ms. Johnson addressed questions and comments from the Commission.

Director Watkins presented the Financial Reports ending September 30, 2014 and addressed questions and comments from the Commission. Commissioner Chotas requested to include a 3-year total for future reports. Ms. Watkins responded affirmatively.

Deputy Director Johnson presented the Application and License Count Reports. Director Watkins and Ms. Johnson addressed questions and comments from the Commission.

#### **Legal Case Activity Report**

Chief Attorney Fier presented the monthly report regarding legal case activity and addressed questions and comments from the Commission.

#### **Escrow Disbursement Orders**

Assistant General Counsel Cheneler presented 6 Escrow Disbursement Orders and 4 Orders for the Commission's consideration.

Vice-Chair Fryer moved to accept 6 Escrow Disbursement Orders (Tabs A-G) and 3 Orders (Tabs I and J); Commissioner Hornsleth seconded the motion; the motion passed without dissent.

Vice-Chair Fryer moved to accept Order Tab H; Commissioner Hornsleth seconded the motion; the motion passed without dissent. Chair Furst recused herself from participation relating to Tab H due to conflict.

escrow account as revealed by a Department audit; Rule 61J2-14.012(2) and thus Section 475.25(1)(e), Florida Statutes when Subject admitted he was not reconciling his escrow account.

Action taken: Settlement Stipulation accepted.

Respondent was present; Respondent was represented by James Harwood, Esquire, also present. Commissioner Podolsky was recused due to participation on the probable cause panel.

Action taken: Settlement Stipulation accepted.

Mr. David represented the department and presented the case to the Commission. The Commission entered into discussion. Commissioner Hornsleth moved; seconded by Commissioner Chotas to accept the Stipulated Settlement. The motion passed without dissent.

Penalty: \$1,000.00 fine; investigative costs; probation for 1 year; 10 hours CE to include a 4-hour escrow management course with the remaining 6 hours in the field of real estate practice generally or real estate office management. #### Electronic Licensing

Director Watkins introduced Deputy Secretary Tim Vaccaro and Director George Ayrish, Division of Service Operations. Director Ayrish provided a brief summary of the services DSO provides and a summary the current licensing process. Mr. Ayrish reported that the Department has been looking into a paperless licensing program and explained the benefits of instituting this process. Mr. Ayrish assured the Commission that the Department will diligently test the program prior to implementation and requested that the Commission provide approval for the Department to implement electronic licensing for real estate licensees. Mr. Ayrish addressed additional questions and comments from the Commission. Upon conclusion of discussion, Commissioner Chotas moved to express the support of the Commission and as a part of that support requests the Department provide periodic reports to the Executive Director; Vice-Chair Fryer seconded the motion; the motion passed without dissent.

Director Watkins stated that Deputy Secretary Vaccaro and Director Ayrish were also here to address the application process relating to applicants with undisclosed criminal history and amending applications. Deputy Secretary Vaccaro reported that other professions have given the Department the authority to contact the applicant and request them to amend the application when there are discrepancies between the original application and the criminal history report. Mr. Vaccaro asked the Commission if they would consider allowing the Department to contact the applicant to amend their application provided the criminal history falls

within the approvable guidelines. Mr. Vaccaro and Mr. Ayrish addressed questions and comments. Vice-Chair Fryer moved to approve streamlining the application process and allow the applicant to amend the application and not forward the application to the Commission provided the application falls within the approvable guidelines; Commissioner Podolsky seconded the motion; the motion passed without dissent.
