**General Information:** \*State registered, licensed and certified appraisers must complete thirty (30) hours of appraiser continuing education as prescribed by the Florida Real Estate Appraisal Board in Rule 61J1-4.003 every renewal period. The 30 required hours can be completed by distance education or classroom. Please note that wherever ACE is required in the above chart, at least 7 hours of the total number of hours required must be the current version of the USPAP/Law update course.

- \* Individuals not renewing by the end of a renewal cycle shall automatically revert to an inactive status. The inactive status may be maintained for 4 years at which time the registration, license, or certification will automatically expire and the individual must requalify in order to become registered, licensed or certified again as an appraiser.
- \* All the reactivation courses can be completed by distance education or classroom.
- An appraiser can reactivate a registration, license or certification according the requirements presented in Rule 61J1-4.007 (see above chart). The reactivation requirements on the above chart are in additional to the 30 hrs of continuing education needed if they are reactivating during a current open renewal cycle.
