FREC Counsel Stern and the Commission discussed potential changes to the rule. The Commissioner received comments from Ms. Marcia Tabak, Counsel for Florida Realtors. After discussion, Ms. Stern stated that she will provide a proposed draft for consideration and workshop at a meeting in the near future.

Special Agenda

Communications Regarding Rule 61J2-10.026, Florida Administrative Code

Executive Director Crawford reported that last month Ms. Stern was going to research whether the Commission should provide guidance without a proper petition for Declaratory Statement. Ms. Stern stated that the Commission may address the questions providing a disclaimer that this is informal discussion and the information that may be fully relied upon.

The Commission addressed the following inquiry relating to Team Advertisement:

Communication relating to whether email addresses and domain names may contain words banned in the rule. The Commission again agreed that a domain name and email address (for both a team and team members) is not considered advertising under rule 61J2-10.026.

Discussion Regarding Permissible Activities of an Unlicensed Assistant

The Commission reviewed the current list of Permissible Activities of an Unlicensed Assistant for possible changes. After discussion, Commissioner Fryer moved to amend the list as discussion; Vice-Chair Ketcham seconded the motion; the motion passed without dissent.

Communication Received From Candace Tamposi

Executive Director Crawford presented communication from Ms. Tamposi requesting the Commission reinstate her null and void real estate broker license based on a hardship. After review and consideration, the Commission denied the request.

Executive Director's Report

Executive Director Crawford stated that she is excited to have Deputy Director Amrita Singh on board and that Division staff is looking forward to working with her.

Chair's Comments

Discussion Relating to Broker Qualifications Standards

Chair Fitzgerald stated a major concern of this Commission is broker qualification standards. She would like this group to weigh in on what can be done to improve this issue. The Commission entered into discussion. Chair Fitzgerald requested to discuss this issue further next month to address the Commissioners' recommendations as to what changes they would like to see relating to broker requirements.
