Vice-Chair Fryer stated the purpose of this workshop is to discuss rule development and recommendations to update Rule 61J2-20.009, Probable Cause Panel, Rule 61J2-3.008, Pre-Licensing Education for Broker and Sales Associate Applicants and Rule 61J2-3.009, Continuing Education for Active and Inactive Broker and Sales Associate Licensees.

Rule 61J2-20.009

The Commission discussed the proposal to include language in Rule 61J2-20.009 delegating authority to the Department to close any case when there is no probable cause. Mr. Tom Thomas, Deputy General Counsel, and Mr. Al Cheneler, Chief Attorney, represented the Department. Vice-Chair Fryer opened the floor for public comment. After much discussion, Commissioner Schwartz moved, seconded by Commissioner Fitzgerald, not to adopt the suggested change to Rule 61J2-20.009. The motion passed without dissent.

Rule 61J2-3.008

The Commission discussed submitting a proposal to include language in Rule 61J2-3.008 to reflect guidelines for Hybrid education. The Commission received comments from Mr. John Greer, Mr. Andy Brown, Ms. Jolita Brazzano, Ms. Karen Climer, Mr. Toby Schifsky, Ms. Rosita Hernandez, Ms. Pamela Kemper and Ms. Linda Crawford. After much discussion by the Commissioners, FREC Counsel and several of the attendees relating to pre-licensure, continuing education rules, and criteria for course approval, Commissioner Schwartz moved, seconded by Commissioner Sanchez, to delete paragraph 2(d) of Rule 61J2-3.008 which reads: "The institution offering distance education courses must provide proof of certification of the delivery method by a third party independent certifying organization approved by the Commission." The motion passed without dissent.

Commissioner Hornsleth moved; seconded by Commissioner Schwartz, to continue the discussion of proposed language relating to paragraphs 2(c)1 and 2(c)2 of Rule 61J2-3.008 and Rule 61J2-3.009 to a future date; the motion passed without dissent. Furthermore, the Commission invited attendees to submit proposed language for review and consideration to the Education Coordinator, Ms. Jocelyn Pomales, prior to the next workshop.

Executive Director's Comments

Executive Director Crawford announced she accepted an opportunity with the Florida Real Estate Appraisal Board and would no longer be serving as the Florida Real Estate Commission Executive Director. Ms. Crawford thanked current and former Commissioners, FREC Counsel, Mr. Larry Harris, former Director, Ms. Juana Watkins and the Department for their support. Ms. Crawford further thanked the Commission for their service and tireless efforts toward protecting the consumer and educating the public. The Commission and FREC Counsel thanked Ms. Crawford for her service and well-wishes in her new endeavors.
