FREC - Petitions

Emergency Rule – 61J2ER20 – Use of Live Streaming Technology for Delivery of Approved In-Person Education Courses

FREC Counsel Harris presented the Emergency Rule. The purpose of the Emergency Rule is to allow providers of real estate Pre-Licensure, Post-Licensure, Continuing Education, and Real Estate School Instructor courses to offer any courses prevously approved by the Commission as live/in-person through live-streaming/webinar/video-conferencing technologies for the ninety (90) days the emergency rule will be in effect. The Commission received comments from the audience via GoToMeeting (see attached.) This topic was discussed at length. Commissioner Fitzgerald moved; seconded by Commissioner Sanchez, to approve the Emergency Rule; the motion passed without dissent.

Commissioner Hornsleth moved; seconded by Vice-Chair Fryer; for FREC Counsel Harris to draft the final order for Commission review and move the vote to March 2020. The motion passed without dissent. FREC Counsel Harris presented the details of the drafted Final Order granting the Petition for Declaratory Statement for discussion.
